

MEMBER SPOTLIGHT: CDR David Friel

David was born on October 16, 1941, in Montpelier, VT. He grew up in that area and earned a BA in History from St. Michael's College, Colchester, VT. He adopted two children during his marriage to the late Bonnie Bassett Friel. He married Deb Melton in 2010. The couple moved to Quail Creek in 2018.

David joined US Navy in 1963 and attended the Aviation Officer Candidate school and upon graduation was commissioned as an Ensign in US Navy Reserve. He attended a 14-month Navy Flight Training program in Pensacola,

FL and Corpus Christi, TX and was awarded his US Naval Aviator wings in May 1965. From 1966-1968 while flying P-3 Orion aircraft, he was deployed to Keflavik, Iceland, and SE Asia.

David has served as a P-3 Orion Flight instructor, Safety officer, Admin officer, an Operations Staff Officer, Staff AWS officer and Executive Officer. He retired from the Navy in April, 1987.

David flew continuously for TWA from March, 1987 through October, 2001. As a TWA Captain, he generally flew between NYC and St. Louis.

His hobbies include skiing, hiking, golf. David also serves as a docent at 390th Memorial Museum at the Pima Air and Space Museum. He is a Quail Creek representative to First Tee of Tucson, reading seed Volunteer at Wrightson Ridge Elementary School, Treasurer, and member of Old Pueblo Flight 12 (Tucson) of Daedalians (an association of military Aviators.) And he is an active member of our Chapter.

OCTOBER PROGRAM: Pilot to Recount His Experiences Flying on 9/11

Chapter member and retired TWA pilot David Friel will be the keynote speaker at the Chapter's luncheon meeting on Wednesday, October 25. The luncheon will be held in the Madera Room in La Vista on the La Posada campus. After you enter the La Posada campus at the traffic light, make a left at the



first stop sign. Go to the next stop sign and proceed straight through the intersection. A social period will start at 11:30 with lunch being served at 12noon. Cost will be \$17. The menu and reservation form can be found on page 7.

David Friel started flying in May 1965, first gaining experience as a pilot for the U.S. Navy before transitioning to commercial aviation in the 1980s. The fall of 2001 saw Friel serving as a Captain with Trans World Airlines (TWA).

On the morning of September 11, 2001, Friel was assigned to fly from St. Louis to San Francisco, with a departure time of 8:35 a.m. CDT (9:35 EDT). While awaiting departure in the cockpit of his aircraft, Friel's flight crew learned for the first time about the attacks on the World Trade Center. He will share with the attendees what happened in the next couple of hours and days before he could fly again.

Friel reported that as he approached the end of his flying career (20 years in the US Navy and 17 years with TWA), his impending retirement inspired him to start maintaining a personal journal that detailed his professional background and the flights he piloted over the final 18 months of his career. He believed that a journal would be better than log books because a journal gave him the opportunity to expand on any notable events that happened during a particular flight. As the events of 9/11 unfolded, he noted them so that he could relate his experiences of that day to his family and friends.



In 2022, Friel decided to donate his personal flight journal to the 9/11 Museum's permanent collection. He believed it would have more educational value in a museum rather than in his family's memorabilia. He serves as a docent with the 390th Memorial Museum in Tucson and knows first-hand how the personal stories of the men from the 390th Bomb Group impact their visitors.

MAJOR GENERAL TED MAXWELL TO SPEAK AT NOVEMBER LUNCHEON

Major General Ted Maxwell (USAF Retired) will be the presenter at the Chapter's luncheon on Wednesday, November 15. The event will be held in the Madera Room in La Vista on the La Posada campus. A social period will start at 11:30 with lunch being served at 12noon. Cost will be \$17. The reservation form can be found on page 9. At the luncheon, General Maxwell will be talking about what he envisions for the future of the state of Arizona but especially for the Southern Arizona area.

General Maxwell joined the Southern Arizona Leadership Council (SALC) in April 2013 and assumed the role of President and Chief Executive Officer in July 2018. The nearly 140 CEOs, business and community leaders of SALC are actively involved in creating a vibrant future for the Tucson region and state of Arizona by engaging the critical issues of education, infrastructure, healthcare, governance as well as economic growth and innovation.

General Maxwell's extensive leadership and command experience from nearly 34 years of military service have served him well in his role at SALC. He served 15 years on active duty in the Air Force and an additional 19 in the Arizona Air National Guard. He retired as a Major General in 2018. His final military position was as the Commander of the Arizona Air National Guard. In that role he oversaw and was responsible for over 2700 Airmen and the operations of units flying the F-16, the KC-135 and the MQ-9 aircraft supporting the Air Force at home and abroad. He has over 4300 flying hours predominantly in the F-16.

General Maxwell graduated from the United States Air Force Academy in 1984 earning a Bachelor of Science degree. He received his Master's in Business Administration from the University of Arizona in 2014. He is currently serving as the Chair of the Southern Arizona Defense Alliance as well as on the Governor's Water Augmentation, Innovation and Conservation Council. Additionally, he serves on the boards of the Arizona Bowl, the University of Arizona – Applied Research Corporation and the Air Force Museum Foundation as well as the Eller National Board of Advisors.




HIGH ACHIEVING CADETS IN ALL FOUR HIGH SCHOOLS

THE FUTURE OF MORTGAGE RATES

 As a mortgage professional, the question I get asked the most is, "*What is going to happen with mortgage rates?*" Jokingly, I reply that my crystal ball is in the shop, but once it is fixed, I'll ask it what the Powerball numbers are going to be

next week. But in all seriousness, that is a hard question to answer.

For the week ending July 13th, the average rate in the United States hit 6.96%. This is the highest rates have been since November of last year. To put this in perspective, in July 2022 the national average was 5.41% and in 2021, the average rate for the year was 2.96%!

So, what is driving rates up? It is a lot of different factors, but right now, the main component is--Inflation. According to Wikipedia, Inflation is "an increase in the general price level of goods and services in an economy. When the general price level rises, each unit of currency buys fewer goods and services; consequently, inflation corresponds to a reduction in the purchasing power of money." In short, when inflation goes up, it takes more money to purchase goods or services. How does that affect mortgage rates? To fight inflation, the Federal Reserve has been raising the interest rate on the money they lend to banks and other lending institutions. Those lending institutions pass on the rate hike to the consumers on everything from credit cards, car loans, and yes, mortgages.

Given this background, you might ask what does this mean for the future? The answer really depends on how successful the Federal Reserve is at fighting inflation. If they are successful in bringing inflation down, you should see a decrease in mortgage rates. But if they are not successful and inflation goes up, you will see an increase in rates. There are many, many more factors that can change this, such as the strength of the US dollar and investor appetite for mortgage-backed securities, and dozens of other things that affect the world economy. But as far as inflation is concerned, up is bad, down is good.

Having said all of this, I inevitably get asked, "So should I buy a house now, or wait?" My short answer is buy now, refi later. While rates have been going up, the values of homes (over the long term) have not gone down. There is still a strong demand for housing in the Arizona market. There are simply more buyers out there than houses for sale. So, waiting to buy, you are losing possible market appreciation, while rates are just getting higher.

One opinion of all the analysts I follow share that rates will eventually come down. So instead of trying to time the market, I am encouraging my buyers to buy now, minimize the points you pay for the rate, and look at refinancing later (hopefully within the next 2 years.)



Shutdown Averted, But a Real Threat to the All-Volunteer Force Remains

The late-night deal reached Sept. 30 just hours before a full federal shutdown kept the government operating for a few more weeks, but it won't solve years of damage done to the all-volunteer force by fiscally irresponsible lawmakers.

[TAKE ACTION: <u>Ask Your Legislators to Avoid a Government Shutdown and Finish the</u> <u>Appropriations Process</u>]

MOAA has long brought forward the need to end this crippling cycle of continuing resolutions – to fully fund the government before the end of the fiscal year, and to eliminate yet another source of stress and instability from the lives of those in uniform, and of their family members. But as another Oct. 1 came and went, lawmakers again moved the goalposts instead of fulfilling a sacred obligation.

Put bluntly, actions like these damage our national security. Not just because a shutdown would disrupt key services, or because the lack of a full budget means new, innovative programs remain stalled while old, outdated processes move forward. The real threat doesn't come from the balance sheet – it comes from the lack of respect shown toward those who serve from the individuals who are proud to "support our troops."

[TAKE ACTION: <u>Urge Your Elected Officials to Pay Servicemembers During a Federal Funding</u> <u>Lapse</u>]

Elements of that "support" were on full display as the budget deadline closed in:

• Servicemembers had no guarantee of a paycheck should the government shut down. Efforts to secure that guarantee never received a vote in either chamber. And while they included Coast Guard members (an improvement from previous shutdown-related protections), they neglected U.S. Public Health Service and NOAA personnel.

• DoD and VA officials wasted precious resources preparing for contingency operations as military families were left wondering what support would be available at their installation amid extensive furloughs.



· Ultimately, a deal took effect that offered no real fixes – only an extension of this uncertainty.

This dysfunctional behavior comes as the uniformed services face unprecedented recruiting challenges. Even as some in Congress attempt to address recent reports of horrific barracks conditions, the overall message sent by lawmakers is unmistakable – we will not prioritize the care of those willing to sacrifice everything on behalf of our nation.

How does a recruiter make any headway with that message in the headlines? How can military retirees be expected to encourage the service of future servicemembers when evidence suggests those potential recruits will not have the full support of their government?

"Many of our uniformed servicemembers are under financial stress, and endure unacceptable housing conditions and food insecurity, while our nation faces a recruiting crisis," said CW4 Jack Du Teil, USA (Ret), President of <u>The Military Coalition</u>. "Service member pay raises fell 2.6% behind the Employment Cost Index from 2014-16, and Basic Allowance for Housing was reduced 5%, all as cost savings measures on the backs of our uniformed community. The threat of not receiving a paycheck is unacceptable for the members of our eight uniformed services. We urge Congress to rapidly pass the Pay our Troops Act before a lapse in appropriations. Missing a paycheck is a stress our servicemembers should not have to worry about, especially when deployed in harm's way."

MOAA has long worked to ensure the benefits of all who serve – all ranks, all branches – and their families and survivors. That's why we want to encourage our members to do what lawmakers seemingly cannot – keep the budget fight in the spotlight, even when a funding deadline isn't right around the corner.

Send a message to your legislators via <u>MOAA's Legislative Action Center</u> today. Tell them the budget brinksmanship needs to stop – not just to keep the lights on, but to maintain the trust of servicemembers, of veterans, of multigenerational military families who make up the backbone of the all-volunteer force. VA Focuses on Better Patient Advocacy and Resolving Veterans' Complaints

The VA recently updated MOAA and other veterans service organizations on its efforts to improve patient advocacy across its health care system, with details on its Office of Patient Advocacy (OPA) and ways for veterans (and their representatives) to file and track complaints online.

In 2016, Congress required the VA to establish the OPA in the <u>Comprehensive Addition and</u> <u>Recovery Act (CARA)</u>. The office was officially established in 2017 to provide veteran-centered advocacy services and to help resolve health care complaints that cannot be resolved at the point of the health care service.

While medical facilities have always had patient advocates, this is the first time for a department-level office to be established that reports to the undersecretary of the Veterans Health Administration (VHA). The office is charged with providing a centralized and standardized management approach to patient advocacy in the field. The effort aligns the current secretary's vision to provide world class customer service and a modern health care system for veterans.

The law also required the VA to establish a patient advocate tracking system to compile complaint data filed at each medical facility and veterans' satisfaction with such care to assess trends and improve health care services.

What Do Patient Advocates Do?

In short, the patient advocate is the liaison between the veteran and the VA medical facility. The advocate makes sure the veteran's voice is heard and works with other medical staff to address questions and problems.

The words for "patient advocate" may vary by medical facility – patient representative, patient liaison, patient relations, veterans experience, consumer advocate, customer service representative, or another title – but their roles remain the same: They advocate for the veteran and serve as an additional set of eyes and ears for the VA's hospital or clinic operations.



Patient advocates are responsible for:

- Managing the grievance and complaint process.
- · Educating staff and veterans on patient advocacy.
- Explaining health care policies and procedures to veterans.
- · Providing excellent customer service.

• Using mediation and conflict resolution when there is a breakdown in communication between a veteran and staff or provider.

· De-escalating conflict or behavior.

• Providing support to veterans struggling to understand their care plan or navigating the health care system.

- Reporting data and trends to leadership to make system improvements.
- · Serving on various medical facility committees to share the veteran's voice.
- · Reporting suspected veterans abuse or neglect.

There are 650 patient advocates across the VHA – most at VA medical centers, and some at larger community-based outpatient clinics. The OPA provides the necessary policy, guidance, and job-related resources for individual field patient advocacy programs.

Patient Advocate Tracking System and the Complaint Resolution Process

Gone are the days when veteran complaints were case managed via email. Doing away with case management by email has transformed how the VA manages and tracks complaints. The new Patient Advocate Tracking System-Replacement (PATS-R) is the modern cloud-based technology platform where all patient advocate data is entered into a single system.

The VHA has established a standardized process for connecting with veterans to communicate, document, and resolve their complaints. The process integrates with PATS-R to provide real-time



feedback for faster resolution at the lowest level possible and data transparency to target system improvements.

Last year, Congress <u>directed OPA to establish an electronic filing system</u> that would allow veterans or their designated representative to submit an online complaint and to track it through the resolution process. Veterans or their representative can submit a complaint at <u>Ask VA</u> (AVA). The site will allow complaints to be submitted through one of the secure login sites, such as My HealtheVet or ID.me, or without an account.

VA's motto, "patient advocacy is everyone's responsibility," has been fully embraced through the mission and role of the OPA. The OPA's current and future focus is to standardize and refine the roles and responsibilities of the patient advocate workforce and facility and network level advocacy programs and practices. The office hopes its efforts provide a tangible means to build trust with veterans and demonstrates VHA's commitment to delivering the world class health care and customer service they have earned through service.

Surviving Spouse Corner: Is a 55-and-Older Community Right for You?

What is a 55-and-older community? These residential communities are designed to be friendly to seniors with low-maintenance amenities such as pools and clubhouses and close proximity to shopping, restaurants, and attractions. There are more than 19,000 retirement community businesses in the U.S. as of 2023, an increase of 1.2% from 2022, according to <u>IBISWorld.com</u>.

Pros of living in one of these communities include:

• **Like-minded people.** Because of the age requirements, many people living there are likely to be from your generation and share your interests. This will help making new friends easier.

• Activities and events. Many of these communities have a clubhouse where you can find social events, games, movies, concerts, speakers, and more. These activities are usually open to the whole community, so you can participate in as many as you want.

• Less maintenance. You'll probably need to pay an HOA fee for maintenance and repairs, but you won't need to worry about managing the outside of your property. The fee could also include services such as trash collection, cable, water, and security.

• Various amenities. Many of these communities have a pool, a gym, tennis courts, golf, a game room, and more.

• Transportation. Some communities offer shuttles to shopping centers or health appointments.

• Quiet, kid-free environment. Besides holidays when grandchildren can come to visit, most of these communities are quiet.

• **Safety and security.** Many of these communities are gated and have low crime rates. They also often have security staff, well-lit areas, updated fire alarms, smoke detectors, and other safety features.

Having lived in a gated 55-plus community since 2020, I find the only con is that I did not move here sooner. But for some, cons of these communities might include less privacy, higher costs, challenges selling, and younger family members potentially being restricted.

If you're considering moving to a retirement community, before you buy, make a list of other questions and ask the homeowner association (HOA) for answers.

Get a copy of the HOA rules (which are also called restrictive covenants) and fees, and make sure you understand them before you make your decision.
